## ORDER NO. 2 REQUIRING NOTICE AND ESTABLISHING PROCEDURAL SCHEDULE

On October 2, 2006, the Commission Staff (Staff) filed a response to notice and established a procedural schedule in the above styled and numbered docket. Staff recommended that additional notice be provided by the Electric Reliability Council of Texas (ERCOT) and established a procedural schedule for processing this proceeding.

Notice. ERCOT shall provide notice of this application (1) by first-class mail to the parties in Application of the Electric Reliability Council of Texas to Change the ERCOT System Administration Fee, Docket No. 31824 (May 15, 2006) and Application of the Electric Reliability Council of Texas for Approval of a Nodal Market Implementation Surcharge and Request for Interim Relief, Docket No. 32686 (pending); (2) by e-mail exploder for the ERCOT board; and (3) by posting a copy of its petition on the ERCOT website. All such notices should include a copy of the procedural schedule set out below.

**Procedural Schedule.** The following procedural schedule is established for this proceeding:

Deadline for initial comments by interested persons and motions to intervene	October 31, 2006
Deadline for Staff to file comments	November 7, 2005

If no hearing requested, Deadline to file joint proposed order, including findings of fact, conclusions of law, and ordering paragraphs	November 21, 2006
Commission consideration at open meeting	December 1, 2006
