Issue:

Confirmation of the election of the Chair and Vice Chair of the Technical Advisory Committee (TAC).

Background/History:

Section 5.1(g) of the Amended and Restated Bylaws of Electric Reliability Council of Texas, Inc. (ERCOT), as approved on April 16, 2010 (Bylaws), requires that the ERCOT Board of Directors (Board) confirm TAC's election of its Chair and Vice Chair each year. Section 5.1(g) of the Bylaws further provides that the TAC Chair and Vice Chair shall provide full disclosure pursuant to Section 9.2 (Potential Conflicts of Interest) of the Bylaws during the confirmation process.

At the January 6, 2011 TAC meeting, the TAC Representatives elected Brad Jones of Luminant Generation Company LLC, and Kenan Ogelman of CPS Energy, as Chair and Vice Chair of TAC, respectively, for the 2011 year. Since their election, both Mr. Jones and Mr. Ogelman have acknowledged their disclosure obligations pursuant to Section 9.2 of the Bylaws.

Key Factors Influencing Issue:

- The ERCOT Bylaws require Board confirmation of TAC's election of its Chair and Vice Chair.
- The ERCOT Bylaws require full disclosure by the TAC Chair and Vice Chair pursuant to Section 9.2 (Potential Conflicts of Interest) during the confirmation process.

Alternatives:

1. Confirm the election of Brad Jones and Kenan Ogelman as the TAC Chair and Vice Chair, respectively, for the 2011 year; or
2. Refrain from confirming the TAC Chair and Vice Chair.

Conclusion/Recommendation:

It is respectfully recommended that the Board confirm TAC's election of Brad Jones and Kenan Ogelman as TAC Chair and Vice Chair, respectively, for the 2011 year.
