ERCOT Board of Directors (ERCOT Board) Meeting Date: May 17, 2011

Issue:

Consideration of SCR764 – Public Access to Select Market Information System (MIS) Dashboards – URGENT.

Background/History:

Unless otherwise noted all Market Segments were present for each vote.

- **SCR764 – Public Access to Select MIS Dashboards [MIS User Group] – URGENT.**
Proposed Effective Date: Upon System Implementation – Priority Critical; Rank 9.21.
ERCOT Impact Analysis: \$100 to 125k; no impacts to ERCOT staffing; impacts ERCOT systems – Current Day Reports (CDR), MIS, and ERCOT.com; no impacts to ERCOT business functions; no impacts to grid operations and practices.
Revision Description: This SCR proposes system changes to allow public access to a graphical view of non-confidential system conditions and pricing information for the following MIS Dashboards: Load Forecast vs. Actual, Locational Marginal Pricing (LMP) Contour Map, Security Constrained Economic Dispatch (SCED) Up/Down, LMP Ticker with Selected Prices, and Real-Time System Conditions.
TAC Decision: On May 5, 2011, TAC unanimously voted to recommend approval of SCR764 as recommended by the Protocol Revision Subcommittee (PRS) in the April 21, 2011 PRS Report. Credit review not applicable.
