



ERCOT Headcount, January 2008 – August 2011






ERCOT Employment Trend Analysis, Jan 2008 – August 2011

Benefits - Employee Wellness Initiatives

401k Plan

- Successful transition of the ERCOT 401(k) Savings Plan to the Fidelity's Direct platform. This transition was effective August 1, 2011.
- The new platform offers new account features to participants i.e. online beneficiary designation option, offer's lower fees for participants. ERCOT anticipate the average expense ratio of the investments in the Plan will reduce from 0.68% to 0.64%.
