## **Issue:**

Ratification of Jerry Dreyer as an Officer of Electric Reliability Council of Texas, Inc. (ERCOT) with the title of Vice President and Chief Information Officer for the 2011 year and for a term while employed not to exceed one year.

## **Background/History:**

Section 8.2 of ERCOT's Amended and Restated Bylaws, as approved on April 16, 2010 (Bylaws), requires that the ERCOT Board of Directors (Board) ratify ERCOT Officers for terms not to exceed one year. Officers may be re-elected or re-ratified for consecutive terms without limitation.

Jerry Dreyer, most recently employed by ERCOT as Director of Application Services, has agreed to accept the responsibilities associated with Vice President and Chief Information Officer. For this reason, Mr. Dreyer is being recommended as an ERCOT Officer with the title of Vice President and Chief Information Officer.

#### **Key Factors Influencing Issue:**

- The Bylaws require the ratification of Officers at least annually.
- ERCOT must have Officers to perform its statutory and corporate functions.

#### **Alternatives:**

- 1. Ratify the Officer at the September 20, 2011 Board meeting; or
- 2. Defer the ratification of the Officer to a later ERCOT Board meeting.

### **Conclusion/Recommendation:**

At its September 20, 2011 Board meeting, the ERCOT Board should ratify Jerry Dreyer as Vice President and Chief Information Officer for the 2011 year and for a term while employed not to exceed one year.
