

IMPACTS OF ECONOMY & WEATHER - 2012






ELECTRIC VEHICLE TRANSPORTATION & ELECTRICITY CONVERGENCE (EV-TEC)

An industry/university cooperative research center, including UT Austin and Texas A&M


- Center for studying massive plug-in electric vehicle use, their integration into transportation and electric systems, and the development of sustainable strategies to support their use.

Cyber Security

ERCOT and the Southwest Power Pool co-sponsored the Joint Critical Infrastructure Protection Working Group (CIP WG) meeting on April 19

- Cyber Security presentations by Dept of Energy (DoE), Dept of Homeland Security (DHS), FBI, NERC, ERCOT and SPP
- 80 participants from the two NERC regions
- This joint meeting will continue on an annual basis

ERCOT participated in the White House/DoE Electric Sector Cyber Security Risk Management Maturity Assessment Project

- ERCOT will attend executive-level review meeting in late May
- Anticipate DoE/DHS Report and Recommendations to White House in June
