**Issue for the ERCOT Board of Directors**

**ERCOT Board of Directors Meeting Date:** January 15, 2013

**Item No.:** 14.1

**Issue:**

Election of the CEO and ratification of other Officers of Electric Reliability Council of Texas, Inc. (ERCOT).

**Background/History:**

Section 8.2 of ERCOT's Amended and Restated Bylaws, as approved on April 16, 2010 (Bylaws), requires that the ERCOT Board of Directors (Board) elect the CEO of ERCOT and ratify the remaining ERCOT Officers for terms not to exceed one year. Section 8.2 further provides that officers may be re-elected or re-ratified for consecutive terms without limitation and that all officers shall hold office until their successors are chosen and qualified or until their earlier resignation or removal. Section 7.1 of the Bylaws provides in part that "[t]he CEO shall serve as President of ERCOT."

At its meeting on January 14, 2013, the HR&G Committee will consider the election of CEO and ratification of other Officers as recommended by H.B. "Trip" Doggett, ERCOT President and CEO.

**Key Factors Influencing Issue:**

- The Bylaws require the election of the ERCOT CEO and ratification of other Officers at least annually.
- ERCOT must have a CEO and other Officers to perform its statutory and corporate functions.

**Conclusion/Recommendation:**

The HR&G Committee will consider recommending whether, at its January 15, 2013 Board meeting, the ERCOT Board should re-elect H.B. "Trip" Doggett as President and CEO of ERCOT, while employed for a term not to exceed one year, and should ratify the following ERCOT Officers for the 2013 year, while employed for a term not to exceed one year:

Jerry Dreyer – Vice President and Chief Information Officer;  
Bill Magness – Vice President, General Counsel and Corporate Secretary;  
Charles B. Manning, Jr. – Vice President of Human Resources and Chief Compliance Officer;

Mark Ruane – Vice President of Credit and Enterprise Risk Management;  
Kent Saathoff – Vice President of Grid Operations and System Planning; and  
Vickie Leaday – Assistant Corporate Secretary.
