- Note 3: Benchmark data obtained as of January 31, 2013 for T-Bills and for comparable funds for which quotes are periodically obtained. Funds not currently open for investment are not included in range. Note that due diligence has not been performed on funds included in the benchmark and included funds may not meet ERCOT investment standards.
- Note 4: Monthly holding reports are available for review upon request.
