**Call General Session to Order, Announce Proxies and Segment Alternates (Agenda Item 1)**

Craven Crowell, Board Chairman, determined that a quorum was present and called the Nominating Committee (Committee) meeting to order at approximately 1:04 p.m. Chairman Crowell announced that the Nominating Committee was being convened for the purpose of considering the Unaffiliated Director vacancy which would be created at the expiration of Jorge Bermudez' first term on June 30, 2013. He noted that Shannon Bowling, Segment Alternate for the Independent Retail Electric Provider Segment, would be acting on the Segment's behalf as Eric Hendrick changed employment in late December 2012 and was no longer eligible to serve as Director on the Board pursuant to the Bylaws. Chairman Crowell addressed the following Agenda Items in the order below.

**Election of Committee Chair (Agenda Item 2)**

Mr. Crowell entertained a nomination for the election of Committee Chair.

**Karl Pfirrmann nominated Mr. Crowell as Committee Chair. Andrew Dalton seconded the nomination. Mr. Crowell was elected as Committee Chair by unanimous voice vote with no abstentions.**
