## **Issue for the ERCOT Board of Directors**

**ERCOT Board of Directors Meeting Date:** December 8, 2015

#### Issue:

Modification of April 2016 ERCOT Board and Committee Meeting Schedule.

### **Background/History:**

A member of the Gulf Coast Power Association (GCPA) planning committee contacted ERCOT Legal to advise of a scheduling conflict with ERCOT's April 11-12, 2016 Board and Committee meetings and the GCPA Spring 2016 conference in Houston.

The GCPA advised that the organization reserves its meetings spaces two to three years in advance; and the GCPA's Spring 2016 conference was scheduled prior to ERCOT's 2016 Board meetings being scheduled.

At ERCOT's request, the GCPA has provided its conference schedule through Spring 2018. The only conflicting dates between ERCOT's Board meeting and GCPA conference schedules at this time (assuming that ERCOT maintains it current second Tuesday, even-numbered month schedule) are April 11-12, 2016.

## **Key Factors Influencing Issue:**

- ERCOT Board members may want to attend the GCPA spring conference in Houston.
- An alternate date of April 18-19, 2016 would not present conflicts with major holidays or stakeholder meetings.

#### **Conclusion/Recommendation:**

The HR&G Committee is expected to consider recommending whether the ERCOT Board should modify the Board meeting schedule from April 11-12, 2016 to April 18-19, 2016. If there is support for this schedule modification, the HR&G Committee would recommend Board approval of this modification at its December 8, 2015 meeting.
