### **Issue for the ERCOT Board of Directors**

**ERCOT Board of Directors Meeting Date:** August 8, 2017

**Item No.:** 9.2

#### Issue:

The ERCOT Board of Directors (Board) must set the dates and locations for the 2018 regular meetings of the ERCOT Board and the date for the 2018 Annual Meeting of Members.

### **Background/History:**

Pursuant to Section 4.6(a) of the ERCOT Amended and Restated Bylaws (Bylaws), the ERCOT "Board shall meet at least quarterly, with at least one meeting occurring in conjunction with the Annual Meeting of the Members." The ERCOT Board must set the time and place of the ERCOT Board meetings. Section 1.1 of the ERCOT Board Policies and Procedures provides that "Board meetings are normally held on the third Tuesday of each month when the Board is scheduled to meet, but may be moved by agreement of the Board, provided that the Board shall meet at least quarterly consistent with the Bylaws."

The ERCOT Board would meet at ERCOT's Austin office (currently, the Met Center at 7620 Metro Center Drive in Austin, Texas) at approximately 9:00 a.m. (Central prevailing time) as noted below:

- February 20, 2018
- April 10, 2018
- June 12, 2018
- August 7, 2018
- October 9, 2018; and
- December 11, 2018.

The ERCOT Board should set the date of the 2018 Annual Meeting of ERCOT Members to be called on the same date as the December 2018 ERCOT Board meeting as required by Section 4.6(a) of the Bylaws.

Please note that this schedule would allow for Board meetings on even-numbered months. Committee meetings are expected to be held on the day prior to the Board meetings. If the dates, locations or times of the scheduled meetings change, ERCOT will provide ample notice prior to the dates of affected meetings.



The June 13, 2017 Board presentation on the 2018 ERCOT Board Meeting and Annual Meeting Schedule is attached for additional background information and reference.

### **Key Factors Influencing Issue:**

ERCOT Bylaws Section 4.6(b) and Public Utility Regulatory Act Section 39.1511 require the ERCOT Board to set and provide public notice of the dates and locations of its meetings at least seven days in advance of the meeting.

### **Conclusion/Recommendation:**

At its August 8, 2017 meeting, the ERCOT Board should vote to schedule its regular meetings and the Annual Meeting of Members in the 2018 calendar year, preferably as proposed.

# Summary

- Since 2014, regular Board meetings have been scheduled for six times per year during even-numbered months, typically on the second Tuesday of the meeting month.
  - Held the day after Committee meetings
  - One meeting held on same day as the Annual Meeting of Members
- It would be preferable for the Board to vote on the 2018 Board meeting schedule at the August 8, 2017 Board meeting to allow appropriate planning time for the Board, ERCOT staff and stakeholders.



# Review of 2017 Meeting Schedule

- The 2017 Board meeting schedule appears to be working well for the Board and ERCOT staff.
- The Board has been able to complete its work with this meeting schedule.
- In preparation for the development of the 2018 Board meeting schedule, ERCOT management recommends continuing the even-numbered month schedule.



# **ERCOT Management Recommendation**

- ERCOT management has advised that meetings on evennumbered months worked well
  - The odd-numbered month schedule in 2013 created some internal issues with regard to preparation of meeting materials due to holidays, such as, New Year's Day, Spring Break, Fourth of July, Labor Day and Thanksgiving.
  - An April meeting is needed for the approval of the financial statement audit (to save costs) and for debt covenant compliance, which requires audited financial statements by the end of April.
  - An October meeting allows for consideration and approval of certain items that require year-end approval with sufficient planning time before the end of the year.



# Proposed 2018 Board / Committee Meeting Schedule

## **Proposed February and August 2017 Meeting Dates**

- There are two occurrences in the proposed meeting schedule which would not fall on the second Tuesday of an evennumbered month – February and August 2018
  - February 12 and 13 coincide with the NARUC Conference
  - August 13 and 14 create a travel conflict for the MRC Meetings
- Stakeholder meetings can be adjusted to accommodate both proposed changes, that is, the third Tuesday in February 2018 and the first Tuesday in August 2018
- The proposed October 8 and December 10, 2018 meetings coincide with Columbus Day and the last day of Hanukkah



# **Proposed 2018 Annual Meeting Date**

- For the Annual Meeting of Members, ERCOT's Bylaws require that:
  - Members shall meet at least annually on a date and at a place to be established by the Board (that is, the Annual Meeting).
  - The Board shall meet at least quarterly, with at least one meeting occurring in conjunction with the Annual Meeting.
- When the Board votes to approve the 2018 Annual Meeting, it should be held on the same day as the December 2018 Board meeting, that is, on Tuesday, December 11, 2018, as currently proposed.



# **Board Vote at Next Meeting**

A vote by the Board for the 2018 Board meeting schedule and 2018 Annual Meeting is expected to be requested at the August 2017 Board meeting.
