Notice of Guide Revisions Approved by TAC

RRGRR014, As-Built Clarification for RRGRRs 006, 007, and 009. This Resource Registration Glossary Revision Request (RRGRR) conforms the Resource Registration Glossary to the as-built release as it captures baselines updates subsequent to the approval of RRGRR006, Clarification of Descriptions and Alignment with Resource Asset Registration Forms, and RRGRR007, Adding Solar Resource Registration Inputs, but omitted from the greybox tab for RRGRR009, Adding Voltage Limit Sets, Relay Loadability, MLSE, and GMD Data.

NOGRR170, Alignment with NPRR824, Alignment of EEA Level 3 with NERC Reliability Standards EOP-011-1 and BAL-001-2. This Nodal Operating Guide Revision Request (NOGRR) revises the Nodal Operating Guide (NOG) to be consistent with NPRR824 language relating to North American Reliability Corporation (NERC) Reliability Standards EOP-011-1, Emergency Operations, and BAL-001-2, Real Power Balancing Control Performance.

LPGRR063, **Assignment of BUSOGFLT Profile Type.** This Load Profiling Guide Revision Request (LPGRR) serves to clarify and restrict the wording referring to the Competitive Retailer (CR) of record in regards to the request for a BUSOGFLT Profile Type.

RMGRR149, Clarification to Market Processes for ESI IDs Without a REP of Record. This Retail Market Guide Revision Request (RMGRR) clarifies the Left In Hot communication process and codifies the Left In Hot process for Electric Service Identifiers (ESI IDs) without a Retail Electric Provider (REP) of record in the Retail Market Guide.
