Endorsement of Proposed Amendments to ERCOT Articles of Incorporation and Bylaws

On 7/26/18, TAC unanimously voted to endorse the proposed amendments to the ERCOT Articles of Incorporation and Bylaws.

Notice of Guide Revisions Approved by TAC

RMGRR152, Additional Alignment with NPRR778, Modifications to Date Change and Cancellation Evaluation Window. This Retail Market Guide Revision Request (RMGRR) changes the method of cancellation from using the MarkeTrak Cancel With Approval Process to the 814_08 Cancel Request Electronic Data Interchange (EDI) transaction.

RMGRR153, Modifications to TDSP References and Processes in the Retail Market Guide. This RMGRR removes references to Sharyland Utilities (SU) in the Retail Market Guide because SU no longer operates as a Distribution Service Provider (DSP) in the ERCOT retail market. This RMGRR also updates AEP contact information.

RMGRR154, Remove References to Lite Up Texas. This RMGRR removes references to Lite Up Texas. The Lite Up Texas discount ended in August 2016, and the Retail Market Guide references are no longer applicable.
