
ERCOT is working to define the timing to lift the DGR moratorium based on the target go-live that will be determined over the next few weeks


Previous Plan for Passport Delivery



Delivery sequence priorities

Continue in-flight work:

FFR, DGR/DESR, BES Combo Model, and deliver EMS Upgrade

Expedite ECRS:

- Separate the ECRS project from Passport/RTC
- Deliver as separate project as soon as possible after EMS upgrade

Place remaining Passport scope on-hold for future consideration:

- Remaining scope is RTC, single-model ESR, and DC-Coupled single-model ESR
- Placing program on-hold for <u>at least 1-year</u> (hibernation)
 - ERCOT has already begun to place sub-projects "on-hold"
- Allows room for other work (such as securitization work for House Bill 4492) to proceed and for longer-term policy decisions to be made before potentially resuming at a future date



Next Steps

- ERCOT plans to discontinue "Passport updates" to Board after this meeting.
 - Passport scope items will continue to be maintained as future projects on the Project Priority List.
- At August TAC, ERCOT will provide a final Passport update and propose formally retiring the RTC Task Force (RTCTF).
 - Chartered deliverables were completed in December 2020 related to RTC Protocols.
 - As with other retired task forces, the RTCTF webpage and content will remain available.
- ERCOT has appreciated the time, expertise, and collaboration from the PUCT,
 IMM, and Market Participants on this effort and will stand ready as needed.
