Key Takeaways

- ERCOT continues to utilize frequent Advanced Action Notices and Reliability
 Unit Commitments to maintain grid reliability
- Legislative session concluded with several key bills impacting ERCOT and Market Participants. HB1500 and SB2627 both have market implications
- ERCOT launched TXANS, a new communication tool, and ECRS, a new Ancillary Service
- Hurricane season preparedness and weatherization inspections ongoing




Legislative Update

- Regular Session began January 10, ended May 29 (140 Days)
- More than 250 bills were filed relating to Energy, Public Utility Commission (PUC) or ERCOT
- HB1500 contains market redesign elements and continues the PUC,
 Office of Public Utility Counsel, and ERCOT
- SB2627 relates to funding mechanisms to support the construction, maintenance, modernization, and operation of electric generating facilities
- A special Session was called on May 29 to address property tax relief and border security
 - No topics involving electricity or ERCOT expected in special sessions

Key Takeaway: ERCOT, the Legislature, and PUC share the goal to keep the grid reliable, resilient, and affordable. We are analyzing the suite of electric-related legislation passed to understand what changes are required and their effect on grid operations.



RUC Summary/AANs Issued



Key Takeaway: ERCOT issued several Advanced Action Notices (AANs) to ensure sufficient capacity remained available through the spring outage season.

108.7 effective Reliability Unit Commitment (RUC) Resource-hours in May were due to OSA VDIs for one Resource (SANDHSYD CC1).

ERCOT Contingency Reserve Service (ECRS)

- June 10 procurements began
- 1st new daily procured Ancillary Service in 20 years
- Necessary addition because load and generation are constantly changing due to:
 - Daily load patterns
 - Instantaneous load variation
 - Changes in variable generation output
 - Generators tripping offline

Ancillary Service Products

- Regulation Service (Reg Up and Reg Down)
 - Reserved capacity deployed every 4 seconds to balance supply and demand and maintain frequency close to 60Hz between 5-minute SCED runs
- Responsive Reserve Service (RRS)
 - Reserved capacity procured to respond to low frequency events typically triggered by generating unit trips
- ERCOT Contingency Reserve Service (ECRS)
 - Capacity that can be started in 10 minutes to cover forecast errors or ramps and replace deployed reserves
- Non-Spinning Reserve Service (Non-Spin)
 - Capacity that can be started in 30 minutes to cover forecast errors, forced outages or ramps, and replace deployed reserves until additional resources can be committed

Key Takeaways

2,073 average procured MW/hour

\$25.26 average procured price



Weatherization/Summer Season/Hurricane Preparation

- Implementing weather emergency preparation measures reasonably expected to ensure sustained operations during winter and summer weather conditions
- Submit detailed compliance report to PUC by June 20, addressing whether each generation entity and transmission service provider has submitted the declaration on time, late, or not at all
- 1,098 cumulative inspections to date, well ahead of the required rate
- System Operations Training team providing ERCOT staff detailed hurricane training, including a simulation scenario
- ERCOT holding a severe weather drill (hurricane) with Market Participants

Key Takeaway: ERCOT has initiated summer weatherization inspections and anticipates inspecting approximately 500 facilities between June and September, exceeding compliance requirements of the Weather Emergency Preparedness rule.



Communications Update

- Launched TXANS, a new communication tool to inform the public on grid conditions
- More than 2,100 signed up to receive TXANS notifications in the first week
- Emergency Alert sign ups also increased
- Extensive media coverage
- Social Media Metrics (Facebook, Twitter, LinkedIn)
 - o Impressions: 82,962 (up 295.3%)
 - Engagements: 3,575 (up 247.1%)
 - Link Clicks: 802 (up 174.7%)
 - Audience Gained: 133 (up 62.2%)

Key Takeaway: New dashboards and the Texas Advisory Notification System (TXANS) are examples of ERCOT's commitment to keep Texans informed.
