Annual Membership Meeting Requirements

Texas Business Organizations Code (TBOC) Section 22.153

Must hold an annual meeting of the members at a time that is stated or determined in accordance with the Bylaws

ERCOT Bylaws Section 3.7

Corporate Members shall meet at least annually on a date to be established by the Board

- Date must be in conjunction with a Board meeting, per Section 4.6(a)
- The Record Date for determining Corporate Members entitled to notice of the meeting shall be on the Friday 30-36 days prior to the meeting date
- Written notice, including an agenda, shall be delivered to the Corporate Members entitled to such notice at least three weeks prior to the meeting
