- ERCOT's Money Market Mutual Fund (MMMF) investment yields are consistent with the August yields reported at the prior F&A meeting. As of the end of October 2023, ERCOT's MMMF yields equaled approximately 5.24% and the purchase yield of ERCOT's U.S. Treasury Obligation Portfolio equaled approximately 5.36%
