ERCOT Board of Directors Meeting Date: August 20, 2024

Issue:

Ratification of Officer of Electric Reliability Council of Texas, Inc. (ERCOT), effective July 2, 2024.

Background/History:

Sections 4.10 and 8.2 of the *Amended and Restated Bylaws of Electric Reliability Council of Texas, Inc.* (Bylaws), require that the ERCOT Board of Directors (Board) ratify ERCOT Officers for terms not to exceed one year. Section 8.2 further provides that Officers may be re-elected or re-ratified for consecutive terms without limitation and that all Officers shall hold office until their successors are chosen and qualified or until their earlier resignation or removal.

At its meeting on August 19, 2024, the HR&G Committee will consider the ratification of the following Officer, effective July 2, 2024, for a term while employed not to exceed one year as recommended by Pablo Vegas, ERCOT President and Chief Executive Officer (CEO):

• Gilbert Hughes – Vice President of Public Affairs.

Key Factors Influencing Issue:

- The Bylaws require the ratification of Officers at least annually.
- ERCOT must have Officers to perform its statutory and corporate functions.
- It is preferable to ratify Officers as the CEO promotes or hires executives for certain leadership roles.

Conclusion/Recommendation:

Pablo Vegas, ERCOT President and CEO, has recommended, and the HR&G Committee is expected to recommend, that the Board ratify the following new ERCOT Officer, effective July 2, 2024, for a term while employed not to exceed one year:

Gilbert Hughes, Vice President of Public Affairs.
