# Overview

- **Purpose**

- Provide clarification regarding login credentials for accessing the 2025 Membership Application and Agreement via ERCOT's Public Portal (ServiceNow)
- Address Membership Segment for data and cryptocurrency centers

- **Key Takeaways**

## Accessing ERCOT's 2025 Membership Application & Agreement (review from August TAC meeting)

- Email and Market Notice initiating the 2025 Membership process will contain a link to ERCOT's Public Portal (ServiceNow) that will take applicants directly to the application form
- Link can also be found on ERCOT's Membership webpage
- Applicants **with** existing credentials to ServiceNow will log in and complete the form
- Applicants **without** existing credentials to ServiceNow will need to register using the *New Users Click here to Register* link from the log in screen and complete the *Sign Up* form
  - New users are required to verify their email address after submitting the *Sign Up* form – don't miss this email and this step

# Update Regarding Accessing ERCOT's 2025 Membership Application & Agreement

- ***If*** the Applicant Contact is also the submitting entity's Authorized Representative (AR) or Backup Authorized Representative (BAR):
  - ***and*** used their AR/BAR email address to access the ERCOT Public Portal prior to April 24, 2024, then you may continue to use those credentials.
    - In other words, if you used your AR/BAR email address last year to access the 2024 Membership Application and Agreement, then you will be able to use those credentials this year.

# Update Regarding Accessing ERCOT's 2025 Membership Application & Agreement (continued)

- **If** the Applicant Contact is also the submitting entity's Authorized Representative (AR) or Backup Authorized Representative (BAR):
  - ***and*** did **not** use their AR/BAR email address to access ERCOT's Public Portal prior to April 24, 2024, then the Applicant Contact may **not** use their AR/BAR email address to login to the ERCOT Public Portal and complete the Membership Application – an alternate email address must be used.
    - In other words, if you have been your company's AR/BAR since before April 24, 2024, but have never used your AR/BAR email address to access ERCOT's Public Portal, then you will not be able to use your AR/BAR email address to gain access to the Public Portal; the system will block you.
    - This login issue is scheduled to be resolved next year.

# Update Regarding Accessing ERCOT's 2025 Membership Application & Agreement (continued)

## Notes:

- An AR or BAR who is unable to login to the ERCOT Public Portal may still submit the application if they create **new** login credentials with a different email address not registered with ERCOT as an AR/BAR.
- Membership Application and Agreements do not have to be submitted by your company's AR or BAR.
- It is anticipated that this issue will be resolved for next year's annual Membership Application and Agreement process.

# Data and Cryptocurrency Center Membership Segment

- Under current ERCOT Bylaw definitions
  - although data and cryptocurrency centers don't fit neatly into any one Membership Segment, ERCOT has determined that these entities *fit best* in the Industrial Consumer Segment.
- Having a uniform rule for these centers provides clarity regarding Segment compositions.
- Data and cryptocurrency centers filling out the 2025 Membership Application should therefore apply for the Industrial Consumer Segment.
- In light of the changing composition of the overall market, ERCOT supports a long-term broader discussion of Segment composition, which may include updates to the ERCOT Bylaw's Segment definitions.
