Issue for the ERCOT Board of Directors

ERCOT Board of Directors Meeting Date: September 14-15, 2026

Issue:

Whether to ratify Mahesh Puducheri as Senior Vice President and Chief People Officer of Electric Reliability Council of Texas, Inc. (ERCOT), effective July 6, 2026.

Background/History:

ERCOT must appoint Officers to perform statutory and corporate functions, and the Bylaws require the Board of Directors (Board) to ratify appointments.

At its meeting on September 14, 2026, the HR&G Committee will consider the ratification of Mahesh Puducheri as Senior Vice President and Chief People Officer, effective July 6, 2026, for a term while employed not to exceed one year as recommended by Pablo Vegas, ERCOT President and Chief Executive Officer (CEO).

Key Factors Influencing Issue:

- Section 4.10(c) of the Amended and Restated Bylaws of Electric Reliability Council of Texas, Inc. requires the Board to ratify appointments of ERCOT Officers.
- Section 8.2 of the Bylaws provides that Officer terms will not exceed one (1) year and that Officers may be re-elected or re-ratified for consecutive terms without limitation. Further, all Officers hold office until their successors are chosen and qualified or until their earlier resignation or removal.

Conclusion/Recommendation:

The ERCOT President and CEO has recommended, and the HR&G Committee is expected to recommend, that the Board ratify appointment of Mr. Puducheri as Senior Vice President and Chief People Officer, effective July 6, 2026, for a term while employed not to exceed one year.
